



1 Year Limited Warranty

This Warranty is non-transferable and covers only the original end purchaser of the applicable GabbaGoods Product. Proof of purchase in the form of the original purchase receipt is required for warranty validation and service. We reserve the right to inspect the product and determine whether it is defective in materials or workmanship. If we find that the product is defective, we shall at no charge to you repair or replace the product at our discretion and return the product to you. You are responsible for shipping costs when sending the product to us but there is no charge for the inspection or the return postage within the United States. This warranty does not cover damages resulting from accidental drops, misuse, abuse, tampering, modification, or breakage due to improper care.
