

Warranty

What This Warranty Covers

Fire Avert, LLC solely warrants to the original retail purchaser of this product that the product, when used for its normal, proper, and intended purposes, is free of discernible manufacturing defects. This limited warranty, together with all warranties implied by law and not disclaimed by this limited warranty, if any, shall be limited to a period of one (1) year from the date of purchase by the original retail purchaser. This limited warranty is only valid as to the original retail purchaser and is not transferable or assignable by operation of law or otherwise.

What This Warranty Does Not Cover

This limited warranty does not cover abnormal use or misuse of the product, natural rust formation on any part of the product, or damage caused by accidents, alteration, mishandling, modification, customization, vandalism, negligence, neglect, abuse, abrasion, chemicals, flood, fire, acts of God, or ordinary wear and tear.
