

## Groupon Gift Card Terms And Conditions

- A reference to a "gift card" in these terms and conditions also refers to any electronic code serving the same function.
  - Issued by MyCityDeal Limited, a company registered in England and Wales with registration number 7112363 and registered address at Floors 11-12, Aldgate Tower, 2 Leman Street, London E1 8FA.
  - Redeemable only for Groupon account credits usable to buy products and/or services from [www.groupon.co.uk](http://www.groupon.co.uk).
  - Expires 24 months from date of purchase.
  - To redeem the gift card, you must have an existing account registered with the [www.groupon.co.uk](http://www.groupon.co.uk) website.
  - Cannot be redeemed to buy further Groupon gift cards.
  - Gift cards are not reloadable and cannot be redeemed across multiple Groupon accounts.
  - Upon redemption, the entire balance of the gift card is credited to your Groupon account. Account credits can be used for multiple purchases until the amount credited in your Groupon account has been used up.
  - If the cost of an order exceeds the credit in your account, you must pay for the balance with another available payment method.
  - Gift card cannot be returned or exchanged for a cash refund, except as required by law, in which case the price paid for the gift card will be refunded using the same payment method used to purchase it. A valid form of receipt confirming the purchase of the gift card may be required by Groupon. If you purchase the gift card online you are entitled to cancel your purchase within 14 days of receiving your gift card unless it has already been redeemed.   - Where the gift card is purchased via the [www.groupon.co.uk](http://www.groupon.co.uk) website, Groupon cannot be responsible for any failure or delay in delivery of the gift card to you if caused by events or circumstances beyond Groupon's reasonable control.
  - Groupon reserves the right to close a customer account and request an alternative form of payment if it suspects a gift card has been obtained or is used fraudulently or if there is a breach of any of these terms and conditions.
  - Purchase, use or acceptance of the gift card constitutes acceptance of these terms.

· Groupon reserves the right to change these terms and conditions from time to time in its sole discretion. Terms and conditions at date of purchase of a gift card will continue to apply to that gift card regardless of further changes.
